

ADULT RESIDENTIAL FACILITY UNDERWRITING ACCEPTANCE CRITERIA

- 1. In business three years or acceptable prior eldercare management and elderly caregiving experience
- 2. Clean loss history
- Prohibited residents:
 - a. Mental illness (suicidal, homicidal, self-destructive, schizophrenic, bipolar, etc.)
 - b. Correctional clients
 - c. Sex abusers
 - d. Veterans Administration/mental illness
 - e. Pregnant women/counseling
 - f. Ventilator residents
 - g. Residents that require tube feeding
 - h. Traumatic brain injury
 - Residents permanently confined to a bed (Bedridden refer to Ambulatory Definitions)
 - j. Short-term or recovery residents
- 4. No more than 4 Non-Ambulatory residents, subject to an acceptable Staff Roster including two 2 staff on premises during third shift (bedtime hours) (Refer to Ambulatory Definitions)
- 5. Limited or minor deficiencies from state inspection
- 6. Low/moderate staff turnover rate
- 7. State-specific license designations and per-bed location limitations:
 - a. Arizona Adult Foster Care, Assisted Living Home Directed, Assisted Living Home Personal: 10 Beds
 - b. California Residential Care Facility for the Elderly (RCFE): 6 Beds
 - c. Nevada Adult Group Care Services, Residential Facilities for Groups: 10 Beds
 - d. Oregon Adult Foster Homes: 5 Beds
 - e. Washington Adult Family Homes: 8 Beds
- 8. Prior Retroactive can be added subject to the Insured having current prior claims made coverage in effect

Adult Residential Facilities Ambulatory Definitions

- "Ambulatory" means capable of walking or traversing a normal path to safety without the physical assistance of another individual.
- "Semi-Ambulatory" means physically and mentally capable of traversing a normal path to safety with the use of mobility aids, but unable to ascend or descend stairs without the physical assistance of another individual.
- "Non-Ambulatory" means unable to walk or traverse a normal path to safety without the physical assistance of another individual.

Description of Ambulatory Classification

Ambulatory

- Walks unassisted without aid of any kind
- Walks with the assistance of a cane no assistance needed to get up from a chair or bed

Semi-Ambulatory

- Uses a walker no assistance needed to get from a chair or bed
- Uses a wheelchair no assistance needed to get from a chair or bed

Non-Ambulatory

- Uses a walker or wheelchair 1 person needed to get from chair or bed
- Uses a walker or wheelchair 2 persons needed to get from chair or bed
- Uses a wheelchair Hoyer lift needed to get from bed to chair

• Bedridden/Bedbound - Ineligible

- 100% confined to bed, does not get out of bed due to health reasons, not by resident's choice.
